
The graph shows this property's current and potential energy efficiency.

Primary energy use

The primary energy use for this property per year is 557 kilowatt hours per square metre (kWh/m²).

Environmental impact of this property

One of the biggest contributors to climate change is carbon dioxide (CO₂). The energy used for heating, lighting and power in our homes produces over a quarter of the UK's CO₂ emissions.

An average household produces 6 tonnes of CO₂

This property produces 8.3 tonnes of CO₂
