1 Current Contract Status


Check if you still have legal obligations towards your timeshare contract.

2 Maintenance Fees

No obligations may exist if fees haven't been paid for six years or more.

3 Exit Options

Some companies allow free exits, but beware of excessive fees or unfair terms.

Never deal with cold callers, unsolicited emails, or unexpected letters.

Avoid paying any fees before services are rendered.

Check Regulation

Only work with FCA regulated companies for timeshare exit services.


